NEW BUSINESS:

**A. RIVERFEST 2017**

Charles Craft asked to be on the November 2 Parks Board agenda so he could request permission to use Riverview Park once again for Riverfest 2017. He would like to request the dates of August 3-6. Part of the reason he is requesting the use and the dates so far in advance is that he needs time to line up the entertainment.

**B. DISCUSSION AND POSSIBLE ACTION ON SETTING USAGE FEES FOR OPEN SPACE AREAS IN RIVERVIEW PARK**

The Parks Department was approached by a young lady wanting to get married in Riverview Park between the 6<sup>th</sup> Street Parking Lot (Prum Strasse Parking Lot) and the Old Fort. Currently we do not have any fees set up for individuals requesting to use open space areas in our parks for weddings. The only fees we have set up are for the Kuhlmeier Fountain (\$50.00), Central Park Bandstand (\$50.00) and Old Settlers Park Bandstand (\$50.00). She is planning on a wedding of 75 people and they will be setting up chairs to accommodate the guests. My recommendation would be a fee of \$25.00.
