This week is National Police Week. The City has been informed by the City's insurance company, that the 2001 Pierce fire pumper will have to be replaced. The Lee County HAZ MAT team was activated today for a farm chemical spill west of Houghton. Fire Chief Herren responded and guided Houghton Fire through the process. The 15<sup>th</sup> Street paving project has been delayed due to the hillside weeping. Options being looked at include adding more drainage or more rock. Adding more drainage would delay the project 30 more days and more rock would increase the cost by approximately \$60,000.

#### PRESENTATIONS BY LIAISONS TO BOARDS AND COMMISSIONS

The Main Street Board met this week. The City heard last week BNSF would be closing several crossings for repair this week and asked them to stagger the dates the crossings would be closed. This morning it was learned all the crossings from 6th to 23rd Streets were closed. This caused a problem with construction at the Wastewater Treatment Plant as concrete was scheduled to be poured today.
