TERMS

- 1. This agreement is for the use of winter storage only and such space is to be used at the sole risk of the owner. Current slip renters can transfer boat and trailers into Winter Mooring beginning October 1 with the initial start date of November 1, 2020. Winter Mooring ends March 31, 2021, at which time the owner must have his/her boat and trailer removed from the storage area within 30 days. If the owner does not remove his/her boat and trailer the Park, Recreation and Dock Board will exercise item seven (7) of the Winter Mooring Rules and Regulations. Initials _____
2. Winter Mooring fee is \$100 for current slip renters and \$200 for non-slip renters. If the payment for Winter Mooring has not been paid by November 15th, then the Park, Recreation and Dock Board will exercise item five (5) of the Winter Mooring Rules and Regulations. Initials _____
3. Rental is on a per season basis and will not be prorated. Initials _____
4. Owner is solely responsible for his/her boat and the Park, Recreation and Dock Board assumes no responsibility for the safety of any boat stored and will not be liable for fire, theft or damage to any boat, equipment or property in or on said boat, however arising. Initials _____
5. This agreement is subject to the Riverview Marina Regulations and the same may be amended and are subject to change without notice. A copy of the regulations is posted on the City website. Initials _____
6. Winter Storage Agreements are not transferable. Initials _____

2020/2021 Rules & Regulations

Winter Mooring

1. Current slip renters can transfer boat and trailers into Winter Mooring beginning October 1, once payment has been made. Winter storage shall commence on November 1 and terminate on March 31.
2. Winter storage space shall be used at the sole risk of the boat owner. The owner is solely responsible for his boat and trailer and the City of Fort Madison assumes no responsibility for the safety of any boat stored and will not be liable for fire, theft, or damage to any boat, equipment or property in or on said boat, however arising.
3. A yearly fee of \$100.00 for current slip renters and \$200.00 for non-slip renters shall be charged.
4. Rental is on a per season basis and will not be prorated.
5. Payment is due on or before November 2. If a boat is placed in Winter Mooring and the owner fails to make a payment and submit their winter mooring agreement by 4:30 p.m. on November 2, a notice will be sent allowing until November 15th for them to remove their boat from the marina OR pay the Winter Mooring Fee. If the boat has not been removed or the payment has not been made, the boat will be placed in impound and a \$100 fine plus \$20 per day storage fee will be applied.
6. Winter storage agreements are not transferable.
7. The boat owner must have their boat and trailer removed from the storage area by 4:30pm on April 30th or the boat and trailer will be placed in impound and a \$100 fine and storage fee of \$20 per day will be assessed. Payment will need to be paid at City Hall prior to collecting the boat.
