ORDINANCE AND RESOLUTIONS

RESOLUTION NO. 2018-64, STBG GRANT APPLICATION FOR HWY. 61 & 53rd STREET: Cangas MOVED and Mohrfeld SECONDED to adopt a resolution authorizing the filing of an application with Southeast Iowa Regional Planning Commission for Regional Transportation STBG funds for reconstruction of the intersection of Business 61 and 53rd Street.

Public Works Director Larry Driscoll reported this will add a roundabout and remove the traffic signals. Council discussed the cost of a roundabout versus the cost of adding two dedicated right turn lanes and upgrading the traffic signals. Driscoll has applied for grants to upgrade the traffic signals at every intersection over the last several years and has not received a single grant. With this grant, the cost will be roughly the same as installing two dedicated right turn lanes and upgrading the traffic signals. In addition, the roundabout can be installed without having to acquire additional right-of-way and dealing with the wetlands along the highway. There will also be less maintenance on the lights. The roundabout will be semi traffic friendly with an inner apron on the corners. City Manager David Varley said data shows roundabouts reduce the number of accidents, reduce the severity of accidents and improve traffic flow.

CEMETERY RATE INCREASE: Greenwald MOVED and Andrews SECONDED to adopt a resolution setting cemetery fees.

Mohrfeld said he disagreed with the increase in the Saturday fee. City Clerk Melinda Blind reported that in the last 20 years the number of cemetery staff has been reduced by half and since the new penitentiary opened, the three prison crews the City used for mowing have been eliminated. In order to reduce overtime, Sunday and holiday burials were eliminated in 2007 and higher fees were set for Saturdays. The last increase was two years ago and did not affect the percentage of Saturday burials.

Mohrfeld did not believe it was right to try to influence people's habits by a fee. Rink said when his father passed away Saturday was the only convenient time for his family. Council members discussed overtime within the cemetery department with Driscoll. Mohrfeld suggested raising the burial cost during the work week.

In an effort to reduce the overtime paid out, employees receive half paid overtime, half comp time. Varley said it is harder to schedule projects during the work week for that department if a burial is on Saturday. Department employees also get called out on weekends for parks' issues.

Jan Garza, 20XX Avenue H, said her interpretation of this is that only persons who have money will be able to afford a Saturday funeral. Floyd Krogmeier, 2212 Avenue B, brought up that some families have to travel for funerals.

Mohrfeld suggested raising the rates to \$600 or \$650 Monday through Friday and keeping the Saturday rate at \$850. If Council voted this down, a new resolution could be brought to Council in January.
