MINUTES FORT MADISON CITY COUNCIL Tuesday, February 16, 2021

The City Council met in adjourned session at 5:30 P.M. on Tuesday, February 16, 2021, at City Hall, 811 Avenue E, Fort Madison. Mayor Matt Mohrfeld presided with Council Members Rusty Andrews, Mark Lair, Rebecca Bowker, Tom Schulz, Chad Cangas, Kevin Rink and Donna Amandus present. Lair and Schulz participated via Zoom.

The meeting was held with participants present either in person or electronically (pursuant to lowa Code Section 21.8) due to social distancing issues because of COVID-19.

UPDATE: Downtown Incident: Police Chief Mark Rohloff gave an overview of the events leading up to and an incident in the 800 block of Avenue G on February 7. The police had been at Jus' Try It, a business in that block, following a noise complaint. The owners informed the police there had been a disturbance and the person was asked to leave. Approximately 30 minutes later there were shots fired in the 800 block. An officer was 1 ½ blocks away and responded with 30 seconds. A 43-year old Burlington resident was arrested in connection with this incident. A second suspect has been identified and is being sought. Search warrants have been executed. Rohloff was unable to provide any further report as the investigation is ongoing.

At a questions from Bowker, Rohloff noted the incident did not occur on the premises of Jus' Try It. The owners of the business, Jus' Try It, have been cooperating with the investigation.

<u>DEPARTMENT REPORTS</u>: The police department is the recipient of a grant to receive eight external defibrillators. The Fire Department will serve as honor guard at the funeral of retired firefighter this week. The Fire Department also performed an ice rescue at a slough last week. There have been a lot of calls regarding C02 levels in homes with the extremely cold weather. It has been a snowy week and the street crews have been busy plowing. The Water Department has received a lot of calls concerning frozen pipes.

Concerning the Fiscal Year 2022 Maximum Property Tax Dollars Levy

Mayor Mohrfeld opened the public hearing at 6:05 P.M.

Finance Director Peggy Steffensmeier said the tax levy is not changing. The only change would be if the state changed the residential rollback. There were no other written or oral comments.

Lair had been contacted by a business regarding concerns the installation of trees along the highway would block the view of the river. Public Works Director Mark Bousselot said he spoken to a business owner regarding this. This can be looked at as the project progresses.

RESOLUTION NO. 2021-11, SET PRICE SCHEDULE: Cangas MOVED and Andrews SECONDED to adopt a resolution setting a price schedule for the sale of City-owned property.

Planning Director Doug Krogmeier said the City's process to sell City property/right-of-way includes having a price analysis prepared. This resolution sets a price schedule and streamlines the process. There are several tiers which reflect whether the property is improved or has easements.

RISK/RESILIENCE ASSESSMENT: Bowker MOVED and Amandus SECONDED to approve the Mayor's signature on a Professional Services Agreement with HR Green for a Risk and Resilience Assessment for the water plant and distribution system.

Bousselot reported this will look for risks to the water system and the resilience of sensitive components. Some changes may be needed following completion of the assessment. This is federally mandated and must be done by June 30.

PRE-TREATMENT PROGRAM ASSISTANCE: Bowker MOVED and Andrews SECONDED to approve the Mayor's signature on a Professional Services Agreement with Stanley Consultants for Pre-Treatment Program Assistance.

Bousselot reported the Department of Natural Resources discovered on a 2011 permit the City was not in compliance with the Pre-Treatment Streamlining Rule. The DNR is requiring this be completed by April 1.

HR GREEN AMENDMENT #2: Bowker MOVED and Amandus SECONDED to approve the Mayor's signature on Amendment #2 to a Professional Services Agreement with HR Green for additional quotes, design and construction services for the construction of a 10' wide bridge for the GRHS-FMCH Community Foundation Trail.

Bousselot reported the hospital foundation and SIRRC are providing funding for this.

BRIDGE: Cangas MOVED and Bowker SECONDED to accept the quote of Steffensmeier Welding & Manufacturing, of Pilot Grove, Iowa, in the amount of \$86,156 for a pedestrian bridge for the GRHS-FMCH Community Foundation Trail.

DISCUSSION ITEMS: Fiscal Year 2022 Budget – There were no questions or concerns from Council regarding the proposed FY2022 Budget.

<u>OPEN DISCUSSION/FUTURE MEETINGS AGENDA ITEMS/COUNCIL COMMUNICATIONS:</u> Amandus reported the Dog Park Committee has a donor who will match up to \$5,000 in

donations for the walkways.

The Marina Group is setting up their non-profit. The group is meeting every week by Zoom. Mohrfeld said each part of the marina plan will be contingent on another part. The next step for the City Council will be a lease agreement with the newly-formed non-profit.

MAYOR ANNOUNCEMENTS: The Madison Nursing Home is planning an addition that will double the size of the facility. The business has requested Fort Madison provide a financial incentive.
