It is 12 feet tall and 8½ feet around. Will be located on the river side. He has talked to Joey Herren, Fire Chief, and Herren said it would be okay. Herren suggested Verkryse put some kind of wall around drum so it cannot be knocked over. He also talked to the DNR and they okayed it as long as no cardboard or paper products from the establishment is burned in it.
